The method of payment will be **by cash**.

Bids (Original and Copy) shall be delivered to **Chairman, Local Authority Procurement Committee (LAPC), Local Development Support Project (LDSP), Valikamam East Pradeshiya Sabha , Point Pedro Road , Puttur, Jaffna** on or before **10.30 Hrs** on **26-Mar-2024** Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
9. The Bid shall be valid up to 77 days after the deadline for Bid submission. All bids shall be accompanied by a Bid Security as stated in the Table above.
