2. Bidding will be conducted through **National Competitive Bidding Procedure (NCB)**.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have been registered with the Construction Industry Development Authority (CIDA) in the field of highway construction for grade mentioned in the table below.
 “Bidders shall also register themselves with the Registrar of Public Contracts, Sri Lanka, in terms of the public Contract Act No 03. of 1987”.

Bid number must be written on the left-hand upper corner of the envelope. Late Bids will be rejected.
